Part 1—Preliminary

1 Name

This is the *Biosecurity (First Point of Entry—Cairns Airport) Determination 2016*.

2 Commencement

- (1) Each provision of this instrument specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

3 Authority

- (1) This instrument is made under subsection 223(1) of the *Biosecurity Act 2015*.
- (2) This instrument is made as permitted by subitem 1(1) of Schedule 3 to the *Biosecurity (Consequential Amendments and Transitional Provisions) Act 2015*.

4 Definitions

Note: A number of expressions used in this instrument are defined in the *Biosecurity Act 2015*, including the following:

- (a) aircraft;
- (b) animal;
- (c) goods.

In this instrument:

aircraft means aircraft that are subject to biosecurity control.

goods means goods:

- (a) that are subject to biosecurity control; or
- (b) in relation to which an exposed goods order is in force.

Part 2—First point of entry

5 First point of entry—aircraft

Cairns Airport is a first point of entry for aircraft.

6 First point of entry—goods other than animals

Cairns Airport is a first point of entry for goods, other than animals.

7 First point of entry—animals

Cairns Airport is a first point of entry for each of the following classes of animals:

- (a) animals brought or imported into Australian territory from New Zealand;
- (b) fish (live or dead).

Part 3—Biosecurity entry points

Note: No areas of Cairns Airport are designated as biosecurity entry points.

Part 4—Conditions

Note: There are no specified conditions for Cairns Airport.

Part 5—Period of effect

8 Period of effect

This instrument has effect for 3 years beginning on the date this instrument commences.
