# Part 1—Preliminary

#### 1 Name

This is the *Biosecurity (First Point of Entry—Sunshine Coast Airport) Determination 2016.* 

#### 2 Commencement

#### 3 Authority

- (1) This instrument is made under subsection 223(1) of the *Biosecurity Act 2015*.
- (2) This instrument is made as permitted by subitem 1(1) of Schedule 3 to the *Biosecurity (Consequential Amendments and Transitional Provisions) Act 2015.*

#### 4 Definitions

Note:

A number of expressions used in this instrument are defined in the *Biosecurity Act* 2015, including the following:

- (a) aircraft;
- (b) animal;
- (c) goods;
- (d) plant.

In this instrument:

aircraft means aircraft that are subject to biosecurity control.

goods means goods:

- (a) that are subject to biosecurity control; or
- (b) in relation to which an exposed goods order is in force.

### Part 2—First point of entry

#### 5 First point of entry—aircraft

Sunshine Coast Airport is a first point of entry for aircraft.

#### 6 First point of entry—goods other than animals and plants

Sunshine Coast Airport is a first point of entry for goods, other than animals and plants.

#### 7 First point of entry—animals

Sunshine Coast Airport is a first point of entry for domestic cats and domestic dogs brought or imported into Australian territory from New Zealand.

## Part 3—Biosecurity entry points

Note: No areas of Sunshine Coast Airport are designated as biosecurity entry points.

#### **Part 4—Conditions**

Note: There are no specified conditions for Sunshine Coast Airport.

#### Part 5—Period of effect

#### 8 Period of effect

This instrument has effect for 3 years beginning on the date this instrument commences.
