1 Name

3 Authority

- (1) This instrument is made under subsection 229(1) of the *Biosecurity Act 2015*.
- (2) This instrument is made as permitted by subitem 1(1) of Schedule 3 to the *Biosecurity (Consequential Amendments and Transitional Provisions) Act 2015.*

4 Definitions

Note: A number of expressions used in this instrument are defined in the *Biosecurity Act 2015*, including the following:

- (a) goods;
- (b) vessel.

In this instrument:

goods means goods:

- (a) that are subject to biosecurity control; or
- (b) in relation to which an exposed goods order is in force.

vessels means vessels that are subject to biosecurity control.

Part 2—First point of entry

5 First point of entry—vessels

Port of Hobart is a first point of entry for vessels.

6 First point of entry—goods

Port of Hobart is a first point of entry for goods.

Part 3—Biosecurity entry points

Note: No areas of Port of Hobart are designated as biosecurity entry points.

Part 4—Conditions

Note: There are no specified conditions for Port of Hobart.

Part 5—Period of effect

7 Period of effect

This instrument has effect for 3 years beginning on the date this instrument commences.
