**Determination 2016/09:  
Remuneration and Allowances for Holders of Public Office  
and Judicial and Related Offices**

- (i) Pursuant to subsections 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to certain holders of public office, and other matters significantly related thereto, and determines as set out below.

**PART 1 – FULL-TIME OFFICES**

- 1.1** In this part, Determination Number 21 of 2015 (as amended) is referred to as the Principal Determination.
- 1.2** Table 2A of Part 2 of the Principal Determination is amended by deleting the entries for the Chief Executive Officer, CrimTrac, Chief Executive Officer, National Health Performance Authority (NHPA) and the Commonwealth Financial Officer for Norfolk Island.
- 1.3** Table 3A of Part 3 of the Principal Determination is amended by deleting the entry for Ms Nicole Rose, Chief Executive Officer, CrimTrac.
- 1.4** Table 2A of Part 2 of the Principal Determination is amended by replacing “3” in Column 5 of the entry for AAT (former Member, SSAT) with “2”.

**2.2.20 Innovation and Science Australia, Chief Executive Officer:** The Chief Executive Officer will receive an additional fixed loading of \$50,000 for a period of three years from the date of commencement of the inaugural appointee. During this period Base Salary will be \$309,180.
