**Determination 2017/01:
Remuneration and Allowances for Holders of Public Office**

PART 1 – FULL-TIME OFFICES

- 1.1** In this part, Determination Number 19 of 2016 is referred to as the Principal Determination.
- 1.2** Table 3B of Part 3 of the Principal Determination is amended by inserting the following entry after the entry for “Mr Nick Ryan, Chief Executive Officer, Australian Aged Care Quality Agency”.
