1 Section 1

Omit "Renewable Energy (Method for Solar Water Heaters) Determination 2016", substitute "Renewable Energy (Method for Solar Water Heaters) Determination 2016".

2 Step 2.h.iii. of the method in Division B of Part 1 of Schedule 1

Repeal the step.

3 Steps 2.h.iv. to vi. of the method in Division B of Part 1 of Schedule 1

Renumber as Steps 2.h.iii. to v.

4 Step 4 of the method in Division B of Part 2 of Schedule 1

Repeal the step, substitute:

- 4. The percent energy savings,
 - a. for the purpose of defining the peak daily winter load of electrically boosted systems, shall be calculated as per clause 3.14.1 of AS/NZS 4234:2008 (as in force at the commencement of the *Renewable Energy (Electricity) (Method for Solar Water Heaters) Amendment (Correction of Minor Errors) Determination 2017*), except the annual reference energy use shall be as calculated in Step 5.c., and
 - b. for the purpose of defining the peak daily winter load of gas boosted systems, shall be calculated as per clause 3.14.1 of AS/NZS 4234:2008 (as in force at the commencement of the *Renewable Energy (Electricity) (Method for Solar Water Heaters) Amendment (Correction of Minor Errors) Determination 2017*), except the annual reference energy use shall be as calculated in Step 5.d.
- 5 Step 6.a. of the method in Division B of Part 2 of Schedule 1

Omit "Step 5(iii)", substitute "Step 5.c.".

6 Step 6.b. of the method in Division B of Part 2 of Schedule 1

Omit "Step 5(iv)", substitute "Step 5.c.".

7 First dot-point under the heading "Measurement and documentation of pump flow rate and power" in Division C of Part 3 of Schedule 1

Omit "item 2(h)", substitute "Step 2.h.".

8 Second dot-point under the heading "Measurement and documentation of pump flow rate and power" in Division C of Part 3 of Schedule 1

Omit "item 2(g)", substitute "Step 2.g.".
