1 Name

1 Section 7

Repeal the section, substitute:

7 Hourly rate of charge

For this Determination, the hourly rate of charge for each person providing a service or matter to which the rate applies is:

- (a) for a total period less than 1 hour the greater of:
 - (i) \$101; and
 - (ii) the proportion of \$202 equal to the proportion of an hour for which charge is to be made; and
- (b) for each completed hour \$202; and
- (c) for a part of an hour after a completed hour the proportion of \$202 equal to the proportion of an hour for which charge is to be made.

- 8 Part 7 of Schedule 1 (cell at table item 7.1, column 3) Omit "\$2 660", substitute "\$4 040".
- **9** Part 7 of Schedule 1 (cell at table item 7.2, column 3) Omit "\$595", substitute "\$1 414".
- **10 Part 7 of Schedule 1 (cell at table item 7.3, column 3)** Omit "\$8 176", substitute "\$5 959".
- **11 Part 7 of Schedule 1 (cell at table item 7.6, column 3)** Omit "\$595", substitute "\$1 414".
