This instrument is the *Migration (IMMI 17/051: Arrangements for Protection, Humanitarian and Refugee Visas) Instrument 2017.* It may be cited as IMMI 17/051.

2 Commencement

This instrument commences on 1 July 2017.

This instrument is made under subregulation 2.07(5) of the Regulations.

- (2) For paragraphs 1401(3)(a), 1402(3)(a), 1403(3)(a) and 1404(3)(a) of Schedule 1 to the Regulations, the required place and required manner for making an application for a visa is listed in Column 4 of the table in Schedule 1 to this Instrument, for the corresponding visa class in Column 1 and the corresponding class of person in Column 2.
