## 1 Name

  - (e) an application for a Subclass 186 (Employer Nomination Scheme) visa to which subsection 5(2) of IMMI 17/080 applies.

#### *Definition of ANZSCO*

- (2) Subitem (1) does not apply in relation to the repeal of paragraph 9 of the *Specification of Occupations, a Person or Body, a Country or Countries 2016/059*.
