On and after 1 October 2017, proceedings in relation to matters arising under the *Child Support (Assessment) Act 1989* or the *Child Support (Registration and Collection) Act 1988* may not be instituted in, or transferred to, a court of summary jurisdiction in New South Wales mentioned in an item of the following table.
