5 Non-warlike service

For the purposes of the definition of *non-warlike service* in subsection 5C(1) of the *Veterans' Entitlements Act 1986*, service in the Defence Force in an operation mentioned in an item of the following table is non-warlike service for the purposes of that Act if the service:

- (a) is in an area of operation mentioned in that item; and
- (b) occurs during a period mentioned in that item.
