**1. LEGISLATIVE PROVISIONS**

1.1. Name of Legislative Instrument

1.1.1. This instrument is the Vehicle Standard (Australian Design Rule 45/01 – Lighting and Light Signalling Devices not Covered by ECE Regulations) 2006 Amendment 1.

1.2. Commencement

1.2.1. This instrument commences on the day after it is registered.

**2. AMENDMENT OF VEHICLE STANDARD**

2.1. The changes specified in Schedule 1 amend Vehicle Standard (Australian Design Rule 45/01 – Lighting and Light Signalling Devices not Covered by ECE Regulations) 2006.
