**Determination 2018/03:
Remuneration and Allowances for Holders of Public Office and
Judicial and Related Offices**

- (i) Pursuant to subsections 7(3) and 7(4) of the Remuneration Tribunal Act 1973, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to certain holders of public office, and other matters significantly related thereto, and determines as set out below.

PART 1 – FULL-TIME OFFICES

- 1.1** In this part, Determination Number 11 of 2017 (as amended) is referred to as the Principal Determination.
- 1.2** Table 2A of Part 2 of the Principal Determination is amended by deleting “2.2.16” in Column 3 of the entry for Director, Old Parliament House.
- 1.3** The Additional Sub-clauses to Table 2A of the Principal Determination are amended by deleting Sub-clause 2.2.16.
- 1.4** Table 2A of Part 2 of the Principal Determination is amended by replacing the current entry for the “Chief Executive Officer, National Health Funding Body” with the following and placing it after the entry for the “Merit Protection Commissioner”:

- 2.1** In this part, Determination Number 10 of 2017 (as amended) is referred to as the Principal Determination.
- 2.2** Table A of Schedule A of the Principal Determination is amended by deleting the entry for the Private Health Insurance Administration Council.
- 2.3** Table B3 of Schedule B of the Principal Determination is amended by deleting the entries for the "Oil Stewardship Advisory Council", "Central Trades Committee" and "Local Trades Committee".
- 2.4** Table A of Schedule A of the Principal Determination is amended by inserting the following after the entry for the "Prostheses List Advisory Committee":

- 2.6** Clauses 2.2 to 2.5 commence on 29 March 2018.

- 3.1** In this part, Determination Number 9 of 2017 (as amended) is referred to as the Principal Determination.
- 3.2** Table 3 of the Principal Determination is amended by replacing the current entry for "Family Court of Australia" with the following:
