### 6 Prescribed maximum amounts in relation to appeals or new trials

For the purposes of subsection 18(1) of the Act, the prescribed maximum amount in relation to a court specified in column 1 of an item in the following table is the amount specified in column 2 of the item.

Prescribed maximum amounts

1	High Court	\$10,000
2	Federal Court	\$6,000
3	Family Court	\$4,000
4	Supreme Court of a Territory	\$6,000
5	other court of a Territory	\$2,000
