## Part 1—Preliminary

### 1 Name

- (1) This instrument is the *Migration (LIN 18/022: Determination of Daily Maintenance Amounts for Persons in Detention) Instrument 2018*.
- (2) This instrument may be cited as LIN 18/022.

### 2 Commencement

This instrument commences on the day after registration on the Federal Register of Legislation.

### 3 Authority

This instrument is made under subsection 262(2) of the Act.

### 4 Definitions

In this instrument:

*Act* means the *Migration Act 1958*.

*immigration detention* is defined in subsection 5(1) of the Act.

### 5 Schedules

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

## **Part 2—Determination**

### **6 Determination of daily maintenance for persons in detention**

For the purposes of subsection 262(2) of the Act:

- (a) the applicable item row of the table at Schedule 1:
  - (i) determines the daily amount for the keeping and maintaining of a person in immigration detention in Column 1; and
  - (ii) specifies the corresponding place of immigration detention in Column 2; and
- (b) the specified period of time for the maintenance of a person in immigration detention for each item of the table at Schedule 1, begins on the day of commencement of this instrument and continues until 30 June 2019.
