Part 1—Preliminary

1 Name of legislative instrument

This is the ASIC Corporations and Credit (Amendment) Instrument 2018/937.

2 Commencement

This instrument commences on the day after it is registered on the Federal Register of Legislation.

3 Authority

This instrument is made:

- (a) under subsection 926A(2) of the Corporations Act 2001;
- (b) under subsection 109(3) of the *National Consumer Credit Protection Act 2009*;
- (c) under item 41 of Schedule 2 to the *National Consumer Credit Protection (Transitional and Consequential Provisions) Act 2009*;
- (d) for the purposes of subparagraph 47(1)(h)(i) of the *National Consumer Credit Protection Act 2009*;
- (e) for the purposes of subparagraph 47(1)(e)(i) as notionally inserted by regulation 25E and Schedule 2 to the *National Consumer Credit Protection Regulations 2010*.

4 Schedules

Each instrument specified in a Schedule to this instrument is amended as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

5 Application of amendments

- (a) The amendments made by Schedule 1 to this instrument apply on and after 1 November 2018.
- (b) The amendments made by Schedule 2 to this instrument apply on and after the day, under item 72 of Schedule 1 to the *Treasury Laws Amendment (Putting Consumers First—Establishment of the Australian Financial Complaints Authority) Act 2018*, on and after which the amendments made by Part 5 of Schedule 1 to that Act apply.
