## Schedule 1—Amendments

### *Australian Citizenship Regulation 2016*

#### **1 Subsection 16(7)**

Repeal the subsection, substitute:

(7) In this section:

*conversion instrument* means the *Migration (LIN 19/001: Payment of Visa Application Charges and Fees in Foreign Currencies) Instrument 2019* made for the purposes of paragraph 5.36(1A)(a) of the *Migration Regulations 1994* and as in force on 1 January 2019.

*places and currencies instrument* means the *Migration (LIN 19/002: Places and Currencies for Paying of Fees) Instrument 2019* made for the purposes of paragraphs 5.36(1)(a) and (b) of the *Migration Regulations 1994* and as in force on 1 January 2019.
