## About this compilation

### **This compilation**

**Name of Determination**

1.1 This Determination is the *Roads to Recovery List 2019*.

**Definitions**

1.3 Terms that are defined in the *National Land Transport Act 2014* have the same meaning in this Determination.

**Roads to Recovery funding period**

1.4 The funding period in relation to the Roads to Recovery Program is the period commencing on 1 July 2019 and ending on 30 June 2024.

Note: This period is referred to in the *National Land Transport Act 2014* as the 'Roads to Recovery funding period'.

**Funding amounts and recipients**

1.5 The amount of Commonwealth funding specified in column 2 of each item in Schedule 1 is to be provided, during the Roads to Recovery funding period, to the person or body specified in column 1 of that item.

1.6 The amount of Commonwealth funding in column 2 of each item in Schedule 2 is specified on account of the State or area of a State specified in column 1 of that item, but the persons or bodies that are to receive the amount have not yet been decided.

Note: The word 'State' is defined in section 4 of the *National Land Transport Act 2014* to include the Australian Capital Territory and the Northern Territory.
