## 1 Name

This instrument is the *Safety, Rehabilitation and Compensation (Specified Persons and Acts) Declaration 2019*.

## 2 Commencement

This instrument commences on the day after it is registered on the Federal Register of Legislation.

## 3 Authority

This instrument is made under subsection 5(6) of the *Safety, Rehabilitation and Compensation Act 1988*.

## 4 Definitions

In this instrument:

*Act* means the *Safety, Rehabilitation and Compensation Act 1988*.

**Commonwealth authority** has the same meaning it has in the Act.

**Entity** has the same meaning it has in the Act.

**licensed corporation** has the same meaning it has in the Act.

## 5 Declaration of specified persons and acts

For the purposes of subsection 5(6) of the Act:

- (a) a person who is included in a class of persons specified in column 1 of an item in the table in Schedule 1, being a class of persons who engage in activities or perform acts:
  - (i) at the request or direction, for the benefit, or under a requirement made by or under a law, of the Commonwealth; or
  - (ii) at the request or direction, or for the benefit, of a Commonwealth authority or a licensed corporation;is taken to be employed by the Commonwealth as represented by the Entity in column 2 of the item, or by the authority or corporation specified in column 2 of the item, as the case may be; and
- (b) the employment of the person is taken to be constituted by the performance by the person of the acts specified in column 3 of the item.
