#### 1 Name

This instrument is the *Criminal Code (Terrorist Organisation—Al-Qa'ida) Regulations 2019.* 

#### 2 Commencement

(1) Each provision of this instrument specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

#### 5 Terrorist organisation—Al-Qa'ida

- (1) For the purposes of paragraph (b) of the definition of *terrorist organisation* in subsection 102.1(1) of the *Criminal Code*, the organisation known as Al-Qa'ida is specified.
- (2) Al-Qa'ida is also known by the following names:
  - (a) Al-Jihad al-Qaeda;
  - (b) Al Qaeda;
  - (c) Al-Qaeda;
  - (d) Al-Qaida;
  - (e) AQ;
  - (f) The Base;
  - (g) The Group for the Preservation of the Holy Sites;
  - (h) International Front for Fighting Jews and Crusaders;

- (i) Islamic Army;
- (j) The Islamic Army for the Liberation of Holy Places;
- (k) Islamic Army for the Liberation of Holy Sites;
- (l) Islamic Salvation Foundation;
- (m) The Jihad Group;
- (n) New Jihad;
- (o) Usama Bin Laden Network;
- (p) Usama Bin Laden Organisation;
- (q) The World Islamic Front for Jihad against Jews and Crusaders.
