Part 1—Preliminary

1 Name

This is the *Biosecurity (First Point of Entry—Port of Port Kennedy) Determination 2019*.

2 Commencement

- (1) Each provision of this instrument specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

3 Authority

This instrument is made under subsection 229(1) of the *Biosecurity Act 2015*.

4 Definitions

Note: A number of expressions used in this instrument are defined in section 9 of the Act.

In this instrument:

Act means the *Biosecurity Act 2015*.

goods means goods (as defined by section 19 of the Act):

- (a) that are subject to biosecurity control; or
- (b) in relation to which an exposed goods order is in force.

non-commercial vessel has the same meaning as in the *Biosecurity Regulation 2016*.

non-commercial vessel baggage means baggage carried on a non-commercial vessel.

non-commercial vessel waste means waste carried on a non-commercial vessel.

vessel means a vessel (as defined by section 9 of the Act) that is subject to biosecurity control.

waste means goods (as defined by section 19 of the Act):

- (a) that are subject to biosecurity control; and
- (b) that are intended, by the person in charge of the vessel on which the goods are carried, to be disposed of.

Part 2—First point of entry

5 First point of entry—vessels

Port of Port Kennedy is a first point of entry for vessels generally.

6 First point of entry—goods

Port of Port Kennedy is a first point of entry for the following:

- (a) baggage carried on a vessel other than a passenger vessel;
- (b) non-commercial vessel waste.

Note 1: Port of Port Kennedy is not a first point of entry for any other goods.

Note 2: For other matters relating to whether particular goods may be brought into a particular first point of entry, see sections 173 and 174 of the Act (which deal with prohibited goods and conditionally non-prohibited goods) and any determinations made under those sections.

Part 3—Biosecurity entry points

7 Biosecurity entry points—vessels

Each area of Port of Port Kennedy specified in column 2 of an item of the following table is designated as a biosecurity entry point for a vessel, or a vessel included in a class of vessels, specified in column 1 of the item.

Biosecurity entry points—vessels		
Item	Column 1 Vessels	Column 2 Areas
1	Non-commercial vessels	The following areas: (a) Inner Harbour Anchorage Adjacent Main Wharf; (b) Small Vessel Anchorage Point, Horn Island
2	Passenger vessels	The following areas: (a) Brisbane Rock Anchorage; (b) Inner Harbour Anchorage Adjacent Main Wharf; (c) Normanby Sound Anchorage
3	Vessels other than passenger vessels	Main Wharf, Thursday Island
4	Vessels other than the following: (a) non-commercial vessels; (b) passenger vessels	Cargo Wharf, Horn Island

Note: A vessel that has arrived at Port of Port Kennedy must be brought to a biosecurity entry point for the vessel at that port as soon as practicable (see section 246 of the Act).

8 Biosecurity entry points—goods

Each area of Port of Port Kennedy specified in column 2 of an item of the following table is designated as a biosecurity entry point for goods, or goods included in a class of goods, specified in column 1 of the item.

Biosecurity entry points—goods		
Item	Column 1 Goods	Column 2 Areas
1	All of the following: (a) non-commercial vessel baggage; (b) non-commercial vessel waste	The following areas: (a) Inner Harbour Anchorage Adjacent Main Wharf; (b) Main Wharf, Thursday Island (c) Small Vessel Anchorage Point, Horn Island

Note 1: If a vessel has arrived at Port of Port Kennedy and is carrying goods mentioned in the table that are to be unloaded from the vessel, those goods must be brought to a

biosecurity entry point for those goods as soon as practicable (see section 147 of the Act).

Note 2: This determination does not designate biosecurity entry points for other goods for which Port of Port Kennedy is a first point of entry, so the requirement in section 147 of the Act does not apply to the unloading of those other goods.

Part 4—Conditions

9 Conditions—notifying Agriculture Department of changes

- (1) The determination of Port of Port Kennedy as a first point of entry by this instrument is subject to the conditions in this section.
- (2) If the owner (or, if there is more than one owner, an owner) of Port of Port Kennedy becomes aware that there has been, or will be, a change to the business entity operating:
 - (a) Port of Port Kennedy; or
 - (b) a biosecurity entry point at Port of Port Kennedy;the owner (or, if there is more than one owner, an owner) must give the Agriculture Department, in writing, notice of the change as soon as practicable after becoming aware that the change has occurred or will occur.
- (3) If the lessee (if any) (or, if there is more than one lessee, a lessee) of Port of Port Kennedy becomes aware that there has been, or will be, a change to the business entity operating:
 - (a) Port of Port Kennedy; or
 - (b) a biosecurity entry point at Port of Port Kennedy;the lessee (or, if there is more than one lessee, a lessee) must give the Agriculture Department, in writing, notice of the change as soon as practicable after becoming aware that the change has occurred or will occur.
- (4) If a person or body that is responsible for carrying out operations at Port of Port Kennedy proposes to make a change referred to in subsection (5), the person or body must give the Agriculture Department, in writing, reasonable notice of the proposed change.
- (5) For the purposes of subsection (4), the changes are as follows:
 - (a) a change to the procedures at Port of Port Kennedy providing for biosecurity measures to be taken to manage the level of biosecurity risk associated with operations carried out at Port of Port Kennedy;
 - (b) a change to the facilities or amenities available at Port of Port Kennedy for biosecurity officials and human biosecurity officers to perform functions or exercise powers under the Act at Port of Port Kennedy;
 - (c) a change to the procedures at Port of Port Kennedy that may affect the ability of a person who carries out operations at Port of Port Kennedy to identify biosecurity risks associated with those operations;
 - (d) a change to the procedures at Port of Port Kennedy that may affect the ability for biosecurity officials or human biosecurity officials to be informed of any identified biosecurity risks associated with operations carried out at Port of Port Kennedy;
 - (e) a change to the procedures at Port of Port Kennedy for managing any other factors that may contribute to, or affect, the level of biosecurity risk associated with operations carried out at Port of Port Kennedy.
