## Schedule 1—Amendments

#### 1 Section 4 (definition of daily dependent child rebate amount)

Repeal the definition, substitute:

#### daily dependent child rebate amount, for a person, means:

- (a) if the person has one dependent child—79.70 cents; or
- (b) if the person has more than one dependent child—79.70 cents for the first child plus 20.92 cents for each additional child.

#### 2 Section 5 (table item 6)

Repeal the item.

#### 3 Subsection 6(2)

Omit "the date the *Cocos (Keeling) Islands Utilities and Services (Electricity Supply and Services Fees) Amendment (2018 Measures No. 1) Determination 2018* commences", substitute "1 November 2019".
