## Part 1—Preliminary

### 1 Name of legislative instrument

This is the *ASIC Market Integrity Rules (Securities Markets) Determination 2019/1226*.

### 2 Commencement

This instrument commences on the day that is the later of:

- (a) 8 January 2020; and
- (b) 20 business days after the day this instrument is registered on the Federal Register of Legislation.

### 3 Authority

This instrument is made under subrule 6.2.1(4) of the *ASIC Market Integrity Rules (Securities Markets) 2017 (Rules)*.

### 4 Interpretation

- (1) In this instrument, unless the contrary intention appears, capitalised terms have the same meaning as in the Rules.
- (2) In this instrument, *stock code*, in relation to an Equity Market Product, means the unique symbol assigned to the Equity Market Product under Rule 9.2.3 of the Rules.

## **Part 2—Determination**

### **5 Tier 1 Equity Market Products and Tier 2 Equity Market Products**

- (1) Each Equity Market Product whose stock code is set out in the table in Schedule 1 to this instrument is a Tier 1 Equity Market Product.
- (2) Each Equity Market Product whose stock code is set out in the table in Schedule 2 to this instrument is a Tier 2 Equity Market Product.
