| 381 | Fisheries Habitat Restoration Program | <p>To improve the health of fisheries and fish stocks by supporting activities to restore marine and estuarine habitats. This objective also has the effect it would have if it were limited to supporting activities:</p> <ul style="list-style-type: none">(a) to give effect to Australia's obligations under the Convention on Biological Diversity, particularly Articles 8(d), (f) and (i); or(b) directed at fisheries, fish stocks or habitats external to Australia; or(c) funded by way of grants of financial assistance to a State or Territory; or(d) carried out in, or in relation to, a Territory. |
