- (3) To avoid doubt, this instrument does not permit the export of a consignment of sheep if the export of the consignment is prohibited by the *Australian Meat and Live-stock Industry (Prohibition of Export of Sheep by Sea to Middle East—Northern Summer) Order 2020*.
