## 1 Name

This instrument is the *Child Support Legislation Amendment (2020 Measures No. 1) Regulations 2020*.

## 3 Authority

This instrument is made under the following:

- (a) the *Child Support (Assessment) Act 1989*;
- (b) the *Child Support (Registration and Collection) Act 1988*.

## Schedule 1—Amendments

### *Child Support (Assessment) Regulations 2018*

#### **1 Section 10**

Repeal the section.

#### **2 Subsection 13(1)**

Omit all the words after “Act,”, substitute:

the following are prescribed:

- (a) money received by a person as an NDIS amount;
- (b) money received by a person as redress to which the person is entitled under the *National Redress Scheme for Institutional Child Sexual Abuse Act 2018*.

### *Child Support (Registration and Collection) Regulations 2018*

#### **3 Paragraph 9(a)**

Omit “newstart allowance”, substitute “jobseeker payment”.

Insert:

## **Part 8—Application, saving and transitional provisions**

### **39 Application—jobseeker payment**

The amendment of paragraph 9(a) made by the *Child Support Legislation Amendment (2020 Measures No. 1) Regulations 2020* applies in relation to the calendar year beginning on 1 January 2021 and each later calendar year.

### **40 Application—reduction of social security pension or social security benefit to nil**

The amendment of item 16 of the table in Part 1 of Schedule 3 made by the *Child Support Legislation Amendment (2020 Measures No. 1) Regulations 2020* applies in relation to a determination made by the Registrar for the purposes of paragraph 72AA(2)(e) of the Act on or after the commencement of that instrument.

### **41 Application—reduction of veteran’s pension or allowance to nil**

The amendment of item 18 of the table in Part 1 of Schedule 3 made by the *Child Support Legislation Amendment (2020 Measures No. 1) Regulations 2020* applies in relation to a determination made by the Registrar for the purposes of paragraph 72AC(2)(e) of the Act on or after the commencement of that instrument.

Before “Algeria”, insert “Albania”.

After “Algeria”, insert “Andorra”.

**7 Schedule 2**

Omit “Former Yugoslav Republic of Macedonia”.

**8 Schedule 2**

After “Portugal”, insert “Republic of North Macedonia”.

**9 Part 1 of Schedule 3 (table item 16)**

Omit “72AA(1) and (2)”, substitute “72AA(1) and (2) and paragraph 72AA(2)(e) in the case described by subsection 72AA(2A)”.

**10 Part 1 of Schedule 3 (table item 18)**

Omit “subsection 72AC(1)”, substitute “subsection 72AC(1) and paragraph 72AC(2)(e) in the case described by subsection 72AC(3)”.
