6 Exempt welfare payment recipients — specified classes of persons

For subsection 123UGB(2) of the Act, the following class of persons is specified to be exempt welfare payment recipients:

(a) the class of persons each member of which:

- (i) is at least 16 years old; and
- (ii) is receiving special benefit; and
- (iii) is not a nominated visa holder; and
- (iv) is not the principal carer of a child who is aged under 6 years.
