This instrument is the *Social Security (Administration) (Deductible portion*—section 123XPA) Specification 2020.

#### 4 Definitions

Note:

A number of expressions used in this instrument are defined in the *Social Security Act 1991* and *Student Assistance Act 1973*, including the following:

- (a) ABSTUDY;
- (b) living allowance;
- (c) pensioner education supplement

In this instrument:

Act means the Social Security (Administration) Act 1999.

#### **6 Deductible Portions**

For paragraph 123XPA(3)(b) of the Act:

- (a) 50% is specified as the deductible portion of an instalment of a category I welfare payment, other than a category I welfare payment specified in subparagraph (b)(i) or (ii); and
- (b) 100% is specified as the deductible portion of an instalment of the following category I welfare payments:
  - (i) a payment under the scheme known as the ABSTUDY scheme that includes an amount identified as the living allowance; and
  - (ii) a payment under the scheme known as the ABSTUDY scheme that includes an amount identified as pensioner education supplement.
