Purpose of supplementary explanatory statement

This supplementary explanatory statement amends the initial explanatory statement for the *Cape Byron Lighthouse Heritage Management Plan 2020* (F2020L01271) (**the Heritage Management Plan**) in accordance with paragraph 15J(1)(c) of the *Legislation Act 2003*.
