## **Schedule 1—Amendments**

### **Part 1—Amendment of the Bankruptcy Act 2006 (Norfolk Island)**

Omit “\$2,000”, substitute “\$10,000”.

Omit “\$2,000”, substitute “\$10,000”.

**3 Item 38A of Schedule 1 (paragraph (b) of the definition of *statutory minimum* in section 6)**

Omit “\$1,000”, substitute “\$2,000”.

**4 Item 42AB of Schedule 1 (Part 30 (heading))**

Repeal the heading, substitute:

**Part 30—Meetings and company documents**

**5 Item 42AB of Schedule 1 (section 678)**

Repeal the section.
