# 1 Section 4

Insert:

non-ADI lender has the same meaning as in the Banking Act 1959.

# 2 Section 4 (definition of smaller lender)

Repeal the definition, substitute:

#### *smaller lender* means:

- (a) an ADI that:
  - (i) is not able to access a term funding facility provided by the Reserve Bank of Australia using as collateral self-securitised assets that are acceptable to the Bank; and
  - (ii) is not a subsidiary of another ADI where the other ADI is able to access such a term funding facility using as collateral such self-securitised assets; or
- (b) a non-ADI lender; or
- (c) a corporation that would be a non-ADI lender if it were not excluded from being a registrable corporation (within the meaning of the *Financial Sector (Collection of Data) Act 2001)* by one or more of the following provisions of that Act:
  - (i) paragraph 7(2)(i);
  - (ii) paragraph 7(2)(ia);
  - (iii) paragraph 7(2)(j).
