

# Greenhouse and Energy Minimum Standards (Registration Fees) Instrument (No. 2) 2020

### Part 1 Preliminary

#### 1 Name of Instrument

This Instrument is the Greenhouse and Energy Minimum Standards (Registration Fees) Instrument (No. 2) 2020.

#### 2 Commencement

This Instrument commences on the day after it is registered.

#### 3 Revocation

This Instrument revokes the Greenhouse and Energy Minimum Standards (Registration Fees) Instrument (No. 1) 2020.

#### 4 Object

The object of this Instrument is to specify, for the purposes of subsection 8 (1) of the *Greenhouse and Energy Minimum Standards (Registration Fees) Act 2012*, the fees payable in relation to applications under section 41 of the *Greenhouse and Energy Minimum Standards Act 2012* to register models of GEMS products.

#### 5 Interpretation

- (1) Unless the contrary intention appears words and expressions used in this Instrument have the same meaning as given in the *Greenhouse and Energy Minimum Standards Act 2012* and the *Greenhouse and Energy Minimum Standards (Registration Fees) Act 2012.*
- (2) The descriptions in column 4 of Schedule 1 are a generic description of the products covered by the GEMS Determinations listed in column 3 of Schedule 1. They are provided for ease of reference only. Whether a model is covered by a GEMS Determination is determined by the relevant GEMS determination listed in column 3 of Schedule 1.

### Part 2 Fees

#### 6 Fees

Column 2 of Schedule 1 sets out the registration fees specified for registration applications in relation to models of GEMS products covered by the GEMS determinations listed in column 3 of Schedule 1.
