## **3** Authority

This instrument is made under section 33 of the *Industry Research and Development Act 1986*.

## 4 Definitions

In this instrument:

# 5 Prescribed program

- (1) For the purposes of subsection 33(1) of the Act, the National Agricultural Innovation Agenda Program (the *program*) is prescribed.
- (2) The program provides funding to Agricultural Innovation Australia Ltd to assist Agricultural Innovation Australia Ltd to undertake its activities of:
  - (a) developing research and development investment strategies; and
  - (b) funding research and development projects identified by such strategies.
- (3) The purpose of the program is to support investment in research and development which:

- (a) addresses significant issues affecting a number of sectors (including the fishery and forestry sectors) of Australian agriculture; and
- (b) is of national benefit and importance because it is conducive to the increased sustainability, productivity and profitability of Australian agriculture.

#### 6 Specified legislative power

For the purposes of subsection 33(3) of the Act, the powers of the Parliament to make laws with respect to the following are specified:

- (a) foreign corporations, and trading or financial corporations formed within the limits of the Commonwealth (within the meaning of paragraph 51(xx) of the Constitution);
- (b) enterprises and activities that are peculiarly adapted to the government of a nation and cannot otherwise be carried on for the benefit of the nation (see paragraph 51(xxxix) and section 61 of the Constitution).

2
