This instrument is the *Financial Framework (Supplementary Powers) Amendment (Agriculture, Water and the Environment Measures No. 3) Regulations 2021.*

### Schedule 1—Amendments

#### Financial Framework (Supplementary Powers) Regulations 1997

#### 1 Part 4 of Schedule 1AB (table item 368, column headed "Objective(s)")

Omit all the words after "farming practices.", substitute:

This objective has the effect it would have if it were limited to measures:

(a) with respect to postal, telegraphic, telephonic, and other like services (within the meaning of paragraph 51(v) of the Constitution); or

(b) to give effect to Australia's obligations under either or both of the following:

- (i) the Convention on Biological Diversity, particularly Articles 6, 8, 10, 11 and 12;
- (ii) the United Nations Convention to Combat Desertification in those Countries Experiencing Serious Drought and/or Desertification, Particularly in Africa, particularly Articles 5 and 10; or
- (c) that are peculiarly adapted to the government of a nation and cannot otherwise be carried on for the benefit of the nation; or
- (d) in the exercise of the executive power of the Commonwealth; or
- (e) undertaken in, or in relation to, a Territory.
