1 Subsection 5(1) (table items 1 to 4)

Repeal the items, substitute:

1	Heavy vehicle	(a) first examination—\$220.50; (b) subsequent examination—\$152.75
2	Trailer (without brakes), trailer derivative (without brakes), motor cycle, moped or motor carrier	(a) first examination—\$151.60; (b) subsequent examination—\$116
3	Vehicle not covered by table item 1 or 2	(a) first examination—\$182.25; (b) subsequent examination—\$116
4	Any vehicle covered by table item 1, 2 or 3	verifying the vehicle’s identity or specifications—\$128.75
