#### 1 Name

This instrument is the *Great Barrier Reef Marine Park Amendment (Queensland Fisheries Legislation) Regulations 2021.*

## Part 1—Main amendments

### Great Barrier Reef Marine Park Regulations 2019

#### 1 Subsection 5(1)

Insert:

*Commercial Fisheries Regulation* means the *Fisheries (Commercial Fisheries) Regulation 2019* (Qld), as in force from time to time.

*Fisheries Declaration* means the *Fisheries Declaration 2019* (Qld), as in force from time to time.

#### 2 Subsection 5(1) (definition of Fisheries Regulation)

Repeal the definition.

#### 3 Subsection 5(1)

Insert:

*General Fisheries Regulation* means the *Fisheries (General) Regulation 2019* (Qld), as in force from time to time.

#### 4 Subsection 5(1) (definition of *hazardous goods*)

Repeal the definition, substitute:

#### hazardous goods:

- (a) has the same meaning as dangerous goods has in Chapter VII of the Annex to the International Convention for the Safety of Life at Sea, done at London on 1 November 1974, as in force for Australia from time to time; and
- (b) includes noxious liquid substances within the meaning of Part III of the *Protection of the Sea (Prevention of Pollution from Ships) Act 1983.*
- Note: The Convention is in Australian Treaty Series 1983 No. 22 ([1983] ATS 22) and could in 2021 be viewed in the Australian Treaties Library on the AustLII website (http://www.austlii.edu.au).

#### 5 Subsection 5(1) (definition of 'N11' fish)

Omit "Fisheries", substitute "Commercial Fisheries".

#### 6 Paragraph 10(b)

Omit "prescribed as", substitute "prescribed as 'critically endangered wildlife' or".

#### 7 Paragraph 15(2)(a)

Omit "Fisheries Regulation", substitute "Fisheries Declaration".

#### 8 Subparagraphs 15(2)(a)(i), (ii) and (iii)

Repeal the subparagraphs, substitute:

(i) for a cast net—section 154;

- (ii) for a scoop net-section 155;
- (iii) for a seine net-section 156;

#### 9 Paragraph 15(2)(b)

Repeal the paragraph, substitute:

- (b) for a commercial fisher—a seine, cast, scoop or mesh net that complies with the size, measurement and other physical requirements in the following provisions of the Commercial Fisheries Regulation:
  - (i) for a seine net—subsection 42(1) of Schedule 4;
  - (ii) for a cast net-section 119 of Schedule 4;
  - (iii) for a scoop net-section 120 of Schedule 4;
  - (iv) for a mesh net (other than a seine net)-section 121 of Schedule 4.

#### 10 Paragraph 15(3)(a)

Omit "179 of the Fisheries Regulation", substitute "138 of the Fisheries Declaration".

#### 11 Paragraph 15(3)(b)

Repeal the paragraph, substitute:

- (b) for a commercial fisher:
  - (i) while using a seine net, bait netting must be in accordance with sections 138 and 140 of the Fisheries Declaration and subsections 38(6), 38(7) and 42(2) of Schedule 4 to the Commercial Fisheries Regulation; and
  - (ii) while using a cast net for taking 'N11' fish, the fisher must comply with the licence condition in section 38 of the Commercial Fisheries Regulation; and
  - (iii) while using a scoop net for taking 'N11' fish, the fisher must comply with the licence condition in section 38 of the Commercial Fisheries Regulation; and
  - (iv) while using a mesh net (other than a seine net), bait netting must be in accordance with sections 138 and 140 of the Fisheries Declaration and sections 118, 121 and 124 of Schedule 4 to the Commercial Fisheries Regulation and, if the net is used for taking 'N11' fish, the fisher must comply with the licence condition in section 38 of the Commercial Fisheries Regulation;

#### 12 Paragraph 17(1)(d)

Before "if", insert "subject to the limitations prescribed by paragraphs (a), (b) and (c) of this subsection,".

#### 13 Section 18

Omit "Chapters 7 and 11 of the Fisheries Regulation", substitute "Parts 1, 2, 3, 5, 8, 11, 12, 13 and 14 of Schedule 1 to the Commercial Fisheries Regulation and Part 1 of Schedule 8 to the Commercial Fisheries Regulation".

#### 14 Paragraph 27(1)(b)

Omit "Fisheries Regulation", substitute "Queensland fisheries legislation".

#### 15 Subsection 27(2)

Omit "section 475 or Part 5 of Chapter 9 of the Fisheries Regulation", substitute "section 42 of, or Part 7 of Schedule 4 to, the Commercial Fisheries Regulation".

#### 16 Paragraph 30(c)

Omit "prescribed as", substitute "prescribed as 'critically endangered wildlife',".

#### 17 Section 30 (table item 12, column headed "Species")

Omit "Carcharinus", substitute "Carcharhinus".

#### 18 Section 30 (after table item 12)

Insert:

12A Carcharhinus longimanus

Oceanic whitetip shark

#### 19 Section 30 (table item 23, column headed "Common name")

Omit "Scalloped hammerhead", substitute "Scalloped hammerhead shark".

#### 20 Paragraphs 31(b) and (c)

Repeal the paragraphs, substitute:

(b) a regulation made under that Act, to the extent that the regulation applies in the Marine Park;

#### 21 Section 36

Omit all the words from and including "the following laws" to the end of the section, substitute "the requirements of the Queensland fisheries legislation relating to trawling are complied with".

#### 22 Subsection 44(2)

Omit "Regulation", substitute "Declaration".

#### 23 Subsection 44(2) (table heading, column 2)

Omit "Regulation", substitute "Declaration".

#### 24 Subsection 44(2) (table item 1, column 2)

 (ii) holds a primary commercial fishing licence under the Queensland fisheries legislation that authorises trawling in the Mission Beach Leader Prawn Broodstock Capture Area; and

#### 37 Subparagraph 106(1)(a)(iv)

Omit "the maintenance and use of vessel monitoring systems", substitute "vessel tracking equipment".

#### 38 Paragraph 119(1)(b)

Repeal the paragraph, substitute:

(b) the transfer is to occur 20 business days or less before the expiry of the period for which the permission is in force.

#### 39 Paragraph 128(3)(b)

Repeal the paragraph, substitute:

- (b) include in the notice a statement that the holder may, before the end of:
  - (i) 20 business days after the Authority gives the notice to the applicant; or
  - (ii) if the Authority extends that period in accordance with section 253 that extended period;

provide reasons to the Authority why the condition should not be modified.
