Schedule 2—Amendments—Nursing-home type patient contribution

Private Health Insurance (Complying Product) Rules 2015

1 Subrule 8A(3) (paragraph (a) of the definition of *patient contribution*)

Repeal the paragraph, substitute:

(a) in relation to a nursing-home type patient at a public hospital, the following amount for the State or Territory in which the hospital is located:

- (i) Australian Capital Territory - \$65.40;
- (ii) New South Wales - \$65.40;
- (iii) Northern Territory - \$65.40;
- (iv) Queensland - \$65.40;
- (v) South Australia - \$65.40;
- (vi) Tasmania - \$65.40;
- (vii) Victoria - \$65.40; and
- (viii) Western Australia - \$65.40.
