#### 1 Name

## Schedule 1—Amendments

## Health Insurance (General Medical Services Table) Regulations 2021

Omit "stage l (minor)", substitute "minimal".

#### 8 Schedule 1 (item 35637, column 2))

Omit "a service to which any other item in this Group applies", substitute "another laparoscopic procedure".

#### 9 Schedule 1 (item 35641, column 2)

Omit "Endometriosis rAFS stage IV", substitute "Severe endometriosis".

#### 10 Schedule 1 (cell at item 35723, column 3)

Repeal the cell, substitute:

### 11 Schedule 1 (cell at item 35754, column 2)

Repeal the cell, substitute:

Hysterectomy, complex laparoscopic, by any approach, that concurrently requires either extensive retroperitoneal dissection or complex side wall dissection, or both, with any of the following procedures (if performed):

- (a) endometrial sampling;
- (b) unilateral or bilateral salpingectomy, oophorectomy or salpingo-oophorectomy;

(c) excision of ovarian cyst;
(d) any other associated laparoscopy;
