1 Name

This instrument is the Automatic Mutual Recognition (New South Wales) (Notification Requirement—Various) Determination 2022.

2 Commencement

(1) Each provision of this instrument specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

3 Authority

This instrument is made under subsection 42J(4) of the *Mutual Recognition Act* 1992 of the Commonwealth.

4 Simplified outline of this instrument

The purpose of this instrument is to require a person to notify a local registration authority before the person begins to rely on automatic deemed registration under the *Mutual Recognition Act 1992* of the Commonwealth to carry on an activity in New South Wales.

Unless revoked earlier, this instrument will sunset under section 50 of the *Legislation Act 2003* of the Commonwealth (see subsection 42J(5) of the *Mutual Recognition Act 1992* of the Commonwealth). This will generally mean that this instrument will be repealed on the first 1 April or 1 October falling on or after the tenth anniversary of the registration of the instrument on the Federal Register of Legislation.

5 Definitions

In this instrument:

Act means the Mutual Recognition Act 1992 of the Commonwealth.

6 Notification requirement

For the purposes of subsection 42J(4) of the Act, notification is required for the following registrations in New South Wales:

- a) Architect under the Architects Act 2003 (NSW);
- b) Registration or accreditation under the *Building and Development Certifiers Act 2018* (NSW) except;
 - i. registered certifiers fire safety
 - ii. accredited practitioner fire safety
- c) Registration or recognition within the meaning of the *Design and Building Practitioners Act 2020* (NSW) except;
 - i. Design practitioner fire systems (all classes)
 - ii. Design practitioner fire safety engineering
 - iii. Professional engineer fire safety
- d) Driving instructor licences under the Driving Instructors Act 1992 (NSW);
- e) Licence for commercial agents under the Fair Trading Act 1987 (NSW);
- f) Licence or certificate within the meaning of the *Home Building Act 1989* (NSW) except the following categories of work:
 - i. general building work
 - ii. erection of prefabricated metal-framed home additions and structures
 - iii. water plumbing fire protection and fire sprinkler systems
 - iv. mechanical services and medical gas work, medical gas technician work, medical gas fitting work
 - v. electrical wiring, air-conditioning and refrigeration work
- g) Driver authority under the Passenger Transport Act 1990 (NSW);
- h) Licences under the *Pawnbrokers and Second-hand Dealers Act 1996* (NSW);
- i) Licences within the meaning of the Pesticides Act 1999 (NSW);
- Radiation security assessor accreditation and radiation user licence under the Radiation Control Act 1990 (NSW);
- k) Registration under the *Surveying and Spatial Information Act 2002* (NSW) except Surveyor Mining;
- 1) Licence or certificate under the Tow Truck Industry Act 1998 (NSW);
- m) Driller's licence under the Water Act 1912 (NSW);
- n) Licence or authorisation under the Work Health and Safety Act 2011 (NSW).
- *o)* Demolition licences under the *Occupational Health and Safety Regulations* 2001 (NSW)
