#### 1. Name

This is the Vehicle Standard (Australian Design Rule) Lighting Standards Amendment Instrument 2022 (No.1).

#### 2. Commencement

This instrument commences at the start of the day after it is registered on the Federal Register of Legislation.

#### 3. Authority

This instrument is made under section 12 of the Road Vehicle Standards Act 2018 (the RVSA)

Note: Some of the instruments amended by this instrument were made under Section7 of the *Motor Vehicle Standards Act 1989* (the MVSA). The MVSA was repealed on 1July 2021 as part of the introduction of the RVSA by the *Road Vehicle Standards Consequential and Transitional Act 2018*. At the same time, legislative instruments made under section 7 of the MVSA and were in force on 1 July 2021 were taken to be made under section 12 of the RVSA.

#### 4. Schedules

Each instrument that is specified in a schedule to this instrument is amended as set out in the applicable items in the schedule concerned, any other item in a schedule to this instrument has effect according to its terms.
