This instrument is the *Privacy Amendment (NT Home Ownership) Regulations 2023*.

## Schedule 1—Amendments

### *Privacy Regulation 2013*

#### **1 Section 5**

Insert:

*NT Home Ownership* means NT Home Ownership, ABN 85 169 745 141, and includes an agent acting on behalf of NT Home Ownership.

#### **2 At the end of section 8**

Add:

*Northern Territory*

- (7) For the purposes of subsection 6F(1) of the Act:
- (a) NT Home Ownership is prescribed; and
  - (b) the modification set out in subsection (8) of this section is prescribed.
- (8) The Act applies in relation to NT Home Ownership as if subsection 7B(5) of the Act were modified by adding, at the end of the subsection:
- “; and (c) the organisation is not a contracted service provider for a contract with NT Home Ownership.”

#### **3 At the end of subsection 10(1)**

Add:

; (d) NT Home Ownership.

#### **4 At the end of section 13AA**

Add:

; (c) NT Home Ownership.

#### **5 At the end of subsections 14(1) and (2)**

Add:

; (c) NT Home Ownership.
