4 Section 4 (definition of *Natural Disaster Royal Commission*)

After “20 February 2020”, insert “(as amended by any later variations of those Letters Patent)”.

5 Section 4 (definition of *NT Royal Commission*)

Omit “(as amended by Letters Patent dated 9 February 2017, 27 June 2017 and 7 September 2017)”, substitute “(as amended by any later variations of those Letters Patent)”.

6 Section 4 (definition of *Oil-for-Food Inquiry*)

Omit “(as amended by Letters Patent dated 6 February 2006, 10 March 2006, 17 March 2006, 22 June 2006 and 21 September 2006)”, substitute “(as amended by any later variations of those Letters Patent)”.

7 Section 4 (definition of *Royal Commission into Trade Union Governance and Corruption*)

Omit “(as amended by Letters Patent dated 30 October 2014)”, substitute “(as amended by any later variations of those Letters Patent)”.
