#### 13 Transitional provisions—funding rules and variations

- (1) The repeal of item 7 of the table in section 10 of this instrument by the Legislation (Exemptions and Other Matters) Amendment (2024 Measures No. 1) Regulations 2024 does not apply in relation to a legislative instrument (including a legislative instrument varying a set of rules) if the legislative instrument is made:
  - (a) before 1 July 2024 under old Division 1; or
  - (b) between 1 July 2024 and 30 June 2025 under transitional Division 1.
- (2) *Old Division 1* is Division 1 of Part 7 of the *Australian Research Council Act 2001*, as in force before 1 July 2024.
- (3) *Transitional Division 1* is Division 1 of Part 7 of the *Australian Research Council Act 2001*, as:
  - (a) in force immediately before 1 July 2024; and
  - (b) continuing to apply on and after 1 July 2024 under items 15 and 16 of Schedule 3 to the *Australian Research Council Amendment (Review Response) Act 2024*.
