## 1 Name

This instrument is the *Classification (Publications, Films and Computer Games) Legislation Amendment Instrument 2024*.

## 2 Commencement

This instrument commences on the later of:

- (a) the start of the day after this instrument is registered; and
- (b) the same time as the *Classification (Publications, Films and Computer Games) Amendment (Industry Self-Classification and Other Measures) Act 2023* commences.

## 3 Authority

This instrument is made under section 6G (conditional cultural exemption rules), paragraph 20A(2)(e) (modification of unclassified films and computer games) and subsection 21(3) (declassification of classified films or computer games that are modified) of the *Classification (Publications, Films and Computer Games) Act 1995*.

## 4 Definitions

Note: A number of expressions used in this instrument are defined in section 5 of the Act, including the following:

- (a) classified;
- (b) computer game;
- (c) film.

In this determination:

*Act* means the *Classification (Publications, Films and Computer Games) Act 1995*.

## 5 Schedules

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

## **Schedule 1—Extension of conditional cultural exemptions for approved cultural institutions**

### *Classification (Publications, Films and Computer Games) (Conditional Cultural Exemption Rules) Instrument 2015*

#### **1 Section 4 (definition of *relevant material*)**

#### **2 Section 4 (definition of *relevant showing*)**

Omit “or an event organised”.

## **Schedule 2—Classification of modified films by accredited persons**

### *Classification (Publications, Films and Computer Games) (Modifications of Films) Instrument 2015*

#### **1 Paragraph 6(1)(b)**

After “section 5”, insert “; or”.

#### **2 Subsection 6(1)**

After paragraph 6(1)(b), insert:

- (c) an accredited person has classified a modified film under section 22K of the Act.

## **Schedule 3—Classification of modified computer games by accredited persons**

### *Classification (Publications, Films and Computer Games) (Modifications of Computer Games) Instrument 2015*

#### **1 Paragraph 8(1)(b)**

After “section 6”, insert “; or”.

#### **2 Subsection 8(1)**

After paragraph 8(1)(b), insert:

- (c) an accredited person has classified a modified computer game under section 22K of the Act.
