Insert:

- (aa) area-wide licence;
- (ab) area-wide receive licence;
- (ac) PTS licence;

## 2 Subsection 10(4A)

Repeal the subsection, substitute:

- (4A) However, for subsection (4), the part of the Register relating to apparatus licences need not contain the details about the use of the spectrum by the devices authorised to be operated under:
  - (a) an area-wide licence; or
  - (b) an area-wide receive licence; or
  - (c) a PTS licence;

unless there is a condition in:

- (d) the licence; or
- (e) an instrument made under subsection 110A(1) or subsection 110A(2) of the Act that applies to the licence;

to the effect that the Register must contain the details.

## 3 Subsection 10(5A)

Repeal the subsection, substitute:

- (5A) However, for subsection (5), the part of the Register relating to apparatus licences need not contain the details about the devices authorised to be operated under:
  - (a) an area-wide licence; or
  - (b) an area-wide receive licence; or
  - (c) a PTS licence;

unless there is a condition in:

- (d) the licence; or
- (e) an instrument made under subsection 110A(1) or subsection 110A(2) of the Act that applies to the licence;

to the effect that the Register must contain the details.

## 4 Subsection 10(6A)

Repeal the subsection, substitute:

- (6A) However, for subsection (6), the part of the Register relating to apparatus licences need not contain the details about the antennas used by, for or in relation to devices authorised to be operated under:
  - (a) an area-wide licence; or
  - (b) an area-wide receive licence; or
  - (c) a PTS licence;

unless there is a condition in:

- (d) the licence; or
- (e) an instrument made under subsection 110A(1) or subsection 110A(2) of the Act that applies to the licence;

to the effect that the Register must contain the details.

## 5 Subsection 10(7A)

Repeal the subsection, substitute:

- (7A) However, for subsection (7), the part of the Register relating to apparatus licences need not contain the details about the sites where devices authorised to be operated under:
  - (a) an area-wide licence; or
  - (b) an area-wide receive licence; or
  - (c) a PTS licence;

are located, unless there is a condition in:

- (d) the licence; or
- (e) an instrument made under subsection 110A(1) or subsection 110A(2) of the Act that applies to the licence;

to the effect that the Register must contain the details.
