#### **34 Application provision**

The amendment of this instrument made by the *Family Law (Child Abduction Convention) Amendment (Child’s Objection) Regulations 2024* applies in relation to the following proceedings:

- (a) proceedings instituted on or after the day that Schedule 4 to the *Family Law Amendment Act 2023* commences (the **commencement day**);
- (b) proceedings instituted before, and not finally determined by, the commencement day, other than proceedings in respect of which a final hearing has commenced by the commencement day.
