4 Subregulation 16(3) (note)

Omit "subsection 32B(3) of the Act", substitute "subsection 32B(4) of the Act".

5 Subregulation 22AB(1)

Omit "For subparagraphs 39B(1)(b)(i) and (2)(b)(i) of the Act", substitute "For the purposes of paragraphs 39B(1)(a) and (2)(a) of the Act".

6 Subregulation 22AB(2)

Omit "For subparagraphs 39B(1)(b)(ii) and (2)(b)(ii) of the Act", substitute "For the purposes of paragraphs 39B(1)(b) and (2)(b) of the Act".
