



1 Section 6 (definition of dangerous drug fee)

Omit "\$5.18", substitute "\$5.37".

2 Section 6 (definition of extemporaneously-prepared dispensing fee)

Omit "\$10.41", substitute "\$10.71".

3 Section 6 (definition of ready-prepared dispensing fee)

Omit "\$8.37", substitute "\$8.67".

4 Paragraph 12(1)(a) (table)

Repeal the table, substitute:

AHI Tier	Price to pharmacists for maximum quantity	Administration, handling and infrastructure fee for maximum quantity
1	< \$100	\$4.79
2	≥ \$100, ≤ \$2 000	Tier 1 AHI Fee + 5% of the amount by which the price to pharmacists for maximum quantity exceeds \$100
3	> \$2 000	\$95.00 + Tier 1 AHI Fee

5 Section 20 (table)

Repeal the table, substitute:

AHI Tier	Price to pharmacists for maximum quantity	Administration, handling and infrastructure fee

2	≥ \$100, ≤ \$2 000	Tier 1 AHI Fee + 5% of the amount by which the price to pharmacists for maximum quantity exceeds \$100
3	> \$2 000	\$95.00 + Tier 1 AHI Fee
