Act means the Therapeutic Goods Act 1989.

nicotine has the same meaning as in TGO 110.

**TGO 110** means the Therapeutic Goods (Standard for Therapeutic Vaping Goods) (TGO 110) Order 2021.

#### 5 Specified goods—vaping goods

- (1) The goods or classes of goods specified in Part 1 of Schedule 1 are determined to be vaping goods.
- (2) For each item of the table in Part 2 of Schedule 1, the goods or classes of goods specified in column 2, when used, advertised, or presented for use or supply in a way specified in column 3, are determined to be vaping goods.

#### 6 Specified goods-not vaping goods

- (1) The goods or classes of goods specified in Part 1 of Schedule 2 are determined not to be vaping goods.
- (2) For each item of the table in Part 2 of Schedule 2, the goods or classes of goods specified in column 2, when used, advertised, or presented for use or supply in a way specified in column 3, are determined not to be vaping goods.
