### 1 After Part 1

# Part 1A—Fees relating to the export of regulated waste material

### 4A Fees relating to the export of regulated waste material

- (1) This section is made for the purposes of section 155 of the Act.
- (2) The fee for performing a function referred to in column 1 of an item in the following table:
  - (a) is the amount specified in column 2 of the item; and
  - (b) is due and payable at the time specified in column 3 of the item; and
  - (c) is payable by the person specified in column 4 of the item.

- (3) The fee under item 3 of the table in subsection (2) for consideration of an application for renewal of an export licence is not payable if:
  - (a) the application relates to a waste paper and cardboard export licence (within the meaning of the *Recycling and Waste Reduction (Export—Waste Paper and Cardboard) Rules 2024*) that was granted before 1 July 2026; and

- (b) the application is the first application made for renewal of the licence; and
- (c) the information mentioned in subsection 8(2) of those rules was not included in the application made for the initial grant of the licence.
- (4) A fee prescribed by an item of the table in subsection (2) must accompany the application being considered.
  - Note: Paragraph 172(1)(e) of the Act does not require the fee to accompany the application if the fee is waived.

; or (c) waive the whole or part of a fee, or a penalty for late payment of a fee, that is payable under this instrument.

3 A person who applies under section 8 for the whole or part of a fee, or a penalty for late payment of a fee, to be waived A decision by the Minister under that section to refuse to waive the whole or part of the fee, or the penalty for late payment of a fee
